PLEASE READ THIS CAREFULLY.

It affects any rights you may have if you, your dog(s), or anybody you bring along to daycare are injured or otherwise suffer damages while participating in doggy daycare and boarding at Healthy Hound Playground. It also states your responsibilities regarding fees and expectations associated with doggy daycare and boarding at Healthy Hound Playground, LLC.

I, _____ (participant/guardian of dog(s)) hereby agree to the following covenants described below regarding the doggy daycare and boarding program at Healthy Hound Playground, LLC.

I further release, waive, discharge and covenant not to sue Healthy Hound Playground and any of the officers, servants, agents, employees and volunteers of the above-mentioned entities (hereinafter referred to as RELEASEES) for any liability, claim and/or cause of action arising out of or related to any loss, damage or injury, including death, that occurs as a result of my participation in the below-described activities.

1. Participation in doggy daycare and boarding is voluntary. We reserve the right to excuse any dog from daycare or boarding at any time for negative behavior.
2. It is the participant's choice to bring other people to the daycare area at his or her risk and it is the participant's sole responsibility to ensure their safety and well-being.
3. RELEASEES do not guarantee a dog's behavior at any time, during or outside of daycare and boarding. We can only evaluate and supervise to the best of our ability.
4. I further understand that Healthy Hound Playground has relied upon my representation that my dog(s) is in good health and has not injured or shown aggression or threatening behavior to any person or dog in admitting my dog for services at their facility.
5. Participating dogs are to be current on their vaccinations. We require a current DHPP vaccine (3 year), Bordetella (6 month or 1 year) and Rabies vaccine (1 or 3 year) if the dog is old enough. By signing this agreement, you certify that your dog is current on his/her vaccinations. We also require participating dogs to have a negative fecal exam every year and that all dogs over 6 months are spayed or neutered.
6. RELEASEES are not responsible for any incident or accident arising from the travel to the daycare and or boarding sessions or after leaving daycare and or boarding, nor are they responsible for any incident or accident arising from the travel to and from an offsite dog grooming facility should you request your dog(s) be taken for grooming.
7. Healthy Hound Playground hereby has permission to use any photos taken of you and/or your dog during class and or boarding for advertising purposes. Names of owner(s) and/or participant(s) will not be printed or released.
8. Daycare dogs will be supervised at all times. However, any time groups of dogs play off leash together there is a chance for injury. By signing below I'm giving permission for my dog(s) to play off leash with other dogs and play on agility equipment while in the daycare facility. I understand that there are risks and benefits associated with group socialization of dogs. I agree that the benefits outweigh the risks and that I accept the risks. I desire a socialized environment for my dog while attending the services provided by Healthy Hound Playground and while in their care. I understand that while the socialization and play are closely monitored by Healthy Hound

Playground staff to prevent injury, it is still possible that during the course of normal play my dog may receive minor nicks and scratches from roughhousing with other dogs.

9. I further understand that RELEASEES will not be liable, financially or otherwise, for injuries to my dog, me or any property of mine while my dog(s) is participating in services provided by Healthy Hound Playground. I hereby release Healthy Hound Playground of any liability of any kind arising from my dog(s)'s participation in any and all services provided by Healthy Hound Playground.
10. I further understand that I am solely responsible, financially or otherwise, for any harm or damage caused by my dog(s) while my dog(s) is attending any services by Healthy Hound Playground.
11. **I authorize my dog(s) to use the treadmill.** Dogs using the treadmill will be supervised at all times. However, whenever using the treadmill there is a chance for serious injury the least and most common of which can include cut or worn off paw pads and torn nails. By initialing I'm giving permission for my dog(s) to use the treadmill while in Healthy Hound Playground's facility. I understand that there are risks and benefits associated with this activity. I agree that the benefits outweigh the risks and that I accept the risks. I understand the treadmill is kept and made use of in open rooms at Healthy Hound Playground where other dogs that are either on or off-leash may be walking by or participating in such activities. I release Healthy Hound Playground of liability for any injury my dog(s) may sustain as a result of negative behavior my dog(s) or of other dogs, and will be financially responsible for covering the veterinary costs associated with any negative behavior that my dog(s) instigates or participates in that causes harm to another dog(s) as determined by Healthy Hound Playground.
12. I further understand and agree that any problems with my dog(s), behavioral, medical or otherwise will be treated as deemed best by staff of Healthy Hound Playground in their sole discretion, and in what they view as the best interest of the animal. I understand that I assume full financial responsibility and all liability for any and all expenses involved in regards to the behavior and health of my dog(s).
13. If your dog(s) does become ill or injured in what is deemed by RELEASEES as non-emergency, and we are unable to reach you, please indicate your wishes below:
 Please perform whatever services the doctor deems necessary for the best care of my pet until someone can be reached.
 I authorize up to \$_____ to be spent on such medical services.
 Do not administer any non-emergency medical services until specific authorization is given.
14. I understand that if my dog(s) is not picked up on time or by a date specified in a separate agreement I hereby authorize Healthy Hound Playground to take whatever action is deemed necessary for the continuing care of my dog(s). I will pay Healthy Hound Playground the cost of any such continuing care upon demand by Healthy Hound Playground. I understand that if I do not pick up my animal, Healthy Hound Playground will proceed according to guidelines provided by Loudoun County, VA Animal Services. I also acknowledge that I will be fully responsible for all attorneys' fees and associated costs if I abandon my dog(s).

By signing this Disclaimer, Agreement and Waiver, I state that I have read and understand the conditions set forth in this Disclaimer, Agreement and Waiver and that I agree to all conditions set forth herein, and that I sign this voluntary.
